However, the total number of shareholders of Company as on 30th June, 2025 is 5266 but in the shareholding statement the number of shareholders are shown as 5117 due to consolidation on PAN basis. 3. Under Column B4(i), NRI includes total of both Repatriable basis (33870 Shares) and Non-Repatriable Basis (62828 Shares). 4. Under Annexure B, 1st quarter is 31st March, 2025; 2nd quarter is - 31st December, 2024, 3rd quarter is 30th September, 2024, 4th quarter is 30th June, 2024. 5. Under Annexure B, Board approved limit is the sectoral limit. 6. Under Annexure B, limit utilised is of NRI on repatriable basis, as shared by the Registrar and Share Transfer Agent. 7.
